ORDER :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, Sri K. Srinivas, Assistant Engineer/Civil is promoted temporarily to act as Asst. Executive Engineer/Civil with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto and the promotion order is subject to the final outcome in the review petition W.A.M.P. No. 3665/13 in W.A. No.1182/11 pending in the Hon'ble High Court of AP and SLP (Civil) No.66-67 of 2016 pending in the Hon'ble Supreme Court. The promotion order is also subject to the final outcome of WP No.27773 of 2012 pending in the Hon'ble High Court of A.P.

3. The promotion ordered above is subject to passing of limited recruitment test and also the result of Writ Appeal filed by the retired officers of erstwhile A.P.S.E. Board against the judgment in W.P No.2360-91/83 and pending in the Hon'ble Supreme Court and the promotion is also subject to result of Writ Petitions pending in the Hon'ble High Court of A.P., regarding seniority.

4. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganization Act, 2014, besides subject to the outcome of batch of writ petitions No.16849/2015 and others pending before the Hon'ble High Court and also the batch of SLPs (Civil) No.20901/2015 and others pending before the Hon'ble Supreme Court of India.

5. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

6. Sri K. Srinivas, AE/Civil on temporary promotion as AEE/Civil is transferred and posted to the control of Chief Engineer/Civil/VS/Hyderabad in the existing vacancy at Vidyut Soudha/Hyderabad.

7. The Controlling Officer is requested to relieve the above promotee by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Asst. Executive Engineer/Civil.

8. The promotee is requested to assume charge on promotion at the place of posting ordered after obtaining proper relief at the present place of working.

9. The promotee is informed that any request for change of posting will not be entertained and he shall assume charge accordingly after obtaining proper relief within fifteen days from the date of receipt of these orders, failing which he has to forego all the rights both at present and in future for such higher posts. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorised absence, besides treating such period of un-authorised absence as 'DIES-NON'. He shall also be liable for disciplinary action.

10. The date of joining of the candidate on promotion as AEE/Civil will be reckoned as date of commencement of probation.
