O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs–Part-II, as adopted by APTRANSCO, The following **TWO** Assistant Secretaries are promoted temporarily to act as Deputy Secretaries with effect from the date of assumption of charge.

1. Smt. K. Seetha Mahalakshmi, Assistant Secretary.
2. Sri. S. John, Assistant Secretary.

2. The promotions ordered in para-1 above are purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion orders are subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganization Act, 2014. After final bifurcation if there are any changes in seniority it will be reflected and appropriate changes will be made based on Regulation and if the officers who are promoted now are affected by such revision he/she should have to forego the promotion and will be reverted back to the present post.

4. The above promotions are subject to the result of Appeal filed by the retired officers of erstwhile APSE Board against the judgment in W.P.No.2360-91/83 and pending in the Hon'ble Supreme Court and is also subject to result of W.P.No. 4219 of 1978 and W.P. No. 24489/2006 pending in Hon'ble High Court of A.P.

5. Smt. K. Seetha Mahalakshmi, Assistant Secretary on temporary promotion as Deputy Secretary is transferred and posted as Deputy Secretary (Personnel), O/o. The Chief General Manager (HR)/APTRANSCO/VS/Vijayawada.

6. Sri. S. John, Assistant Secretary on temporary promotion as Deputy Secretary is transferred and posted as Deputy Secretary (Legal, Industrial Relations & Regulations) O/o. The Additional Secretary /APTRANSCO/ VS/Vijayawada.

7. The concerned Controlling Officers are requested to relieve the above Assistant Secretaries immediately by making local arrangements pending posting of substitute to enable them to assume charge on promotion as Deputy Secretaries at the place of posting ordered.

8. The promotees are informed that they have to assume charge after obtaining proper relief from the present place of working within 15 days from the date of receipt of the posting orders, failing which they have to forego all the rights both at present and in future for such higher post. If they fail to join duty within the time limit or evade joining duty, such period till they re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON'. They shall also be liable for disciplinary action.

9. The date of joining of the candidates on promotion as Deputy Secretary will be reckoned as date of commencement of probation.
