O R D E R :

Under Regulation 14(a)(1) of A.P.S.E.Board S.Rs – Part-II, as adopted by A.P TRANSCO, Sri M.V. Siva Prasada Rao, Deputy Chief Controller of Accounts is promoted temporarily to act Chief General Manager (Finance)/APPCC with effect from the date of assumption of charge.

2. The promotion ordered in para-1 above is purely temporary for administrative convenience and liable to be terminated at any time without notice and without assigning any reasons thereto.

3. The promotion orders is subject to result of final allocation of State Cadre employees between AP TRANSCO and TS TRANSCO that may occur as per the A.P. Reorganisation Act, 2014, besides subject to the outcome of the M.A.No.1270/2020 in C.A.No.11435/2018 pending before the Honorable Supreme Court of India.

4. After final bifurcation if there are any changes in seniority it will be reflected and appropriate change will be made based on Regulation and if the officer who is promoted now is affected by such revision he should have to forego the promotion and will be reverted back to the present post.

5. The promotion ordered in para-1 above is subject to result of appeals filed by the retired officers of erstwhile APSEB against the judgment in W.P.Nos.2360-91/83 and pending in the Hon'ble Supreme Court.

6. Sri M.V. Siva Prasada Rao, Dy.CCA on temporary promotion as Chief General Manager as ordered above is transferred and posted as Chief General Manager (Finance)/APPCC/Vidyut Soudha/Vijayawada

7. The Controlling Officer is requested to relive the above promotee by making local arrangements pending posting of substitute to enable him to assume charge on promotion as Chief General Manager (Finance)/APPCC.

8. The promotee is requested to assume charge on promotion as Chief General Manager (Finance)/APPCC after obtaining proper relief from the present place of working.

The promotee is informed that no request for change of posting will be entertained and he shall assume charge accordingly after obtaining proper relief within 15 days from the date of relief, failing which he has to forego all the rights both at present and in future for such higher posts. If he fails to join duty within the time limit or evades to join duty such period till he re-joins will be treated as un-authorized absence, besides treating such period of un-authorized absence as 'DIES-NON' and liable for disciplinary action.
