ORDER

In the reference 1st read above, APTRANSCO accorded approval for providing Group Personal Accident Policy for an amount of Rs.10,00,000/- (Rupees Ten Lakhs Only) to the outsourced workers working through 3rd party Agencies in APTRANSCO with premium rate of 472/- (Rs.400/- +GST 18%) (Rupees Four Hundred and Seventy Two only) per person, per annum which includes all taxes and the policy shall cover the risk of outsourced workers working through 3rd Party Agencies in APTransco. The amount of insurance payable under the said policy to cover, when an accidental injury and cause results (during the period of insurance) is as follows:

- a) Death : 100 % of Sum Insured
- b) Permanent Total Disablement : 100 % of Sum Insured
- c) Loss of two limbs/ Two eyes : 100 % of Sum Insured
or One limb and one eye
- d) Loss of one limb or one eye : 50 % of Sum Insured
- e) Permanent Partial Disablement : Varying % of Sum Insured as per policy
(As per Doctors evaluation of Disability)
- f) Temporary Total Disablement : 1 % of Capital Sum Insured per week
subject to a maximum of Rs.5,000/- per week
for a maximum period of 100 weeks. Sum
insured is limited to 24 months Gross Income
subject to Rs.5 lakhs.
- g) Children Educational Benefit : Rs.15,000/- for two dependent children
below the age of 25 Years
- h) Funeral Expenses : 2 % of Sum Insured subject to maximum of
Rs.2,500/-
- i) Expenses for Emergency : Emergency Travel to place of death by
Family Members upto Rs.2,500/-
- j) Accidental Medical Expenses : Rs.50,000/- subject to Actual incurred
or 40% of Valid claim amount.

Premium:

Premium amount with Medical Extension: Rs. 400/- + GST 18% as applicable.

Sum insured:

Capital Sum insured per life is Rs.10,00,000/-.

2. In the reference 2nd read above, the M/s United India Insurance Company Ltd., Vijayawada accepted for renewal of Group Personal Accident Policy with same premium per person (i.e., Rs.400/- + GST) for an amount of 10,00,000/- (Ten Lakhs Only) as was done earlier for a period of one year with effect from 28.03.2020 (Midnight) with the same terms and conditions as stated in para 1 above.

3. After careful consideration the APTransco here by accepts the offer of M/s. United India Insurance Company Ltd., Vijayawada for renewal of providing of Group Personal Accident Policy with same premium per person for an amount of 10,00,000/- (Rupees Ten Lakhs Only) for a period of one year w.e.f. 28.03.2020 (midnight) with the same terms & conditions stated earlier in T.O.O. 1st read above.

4. The compensation received under this scheme does not disentitle the victim or the dependants of deceased for any other amounts under the law in force other than this policy.

5. All the Pay Drawing Officers are directed to send the list of Outsourcing workers to whom the wages are being paid from their pay unit to the Pay Officer/ APTransco/ Vidyut Soudha/Vijayawada for arranging consolidate premium amount to M/s United India Insurance Company Ltd., Vijayawada with a copy to the Additional Secretary/APTransco/ Vidyut Soudha/ Vijayawada.
