APTRANSCO in the references 2nd & 3rd cited issued orders adopting the orders issued by the Government of Andhra Pradesh regarding change in the existing periodicity from 8/16/24 years to 6/12/18/24 for appointments under the Automatic Advancement Scheme who are coming under workmen and other than workmen categories in the scale of pay of Rs.30600-1280-37000-1430-44150-1585-45735 in APTRANSCO and below as indicated in the Revised Pay Scales, 2010.

2) In the reference 4th cited, orders were issued directing that an employee on completion of 12 years of service in the cadre of DE/SAO/AS shall be appointed to SPP-IA in the time scale of SE/Dy.CCA/DS by sanctioning one increment in the said scale.

3) Numerous requests from the SE, CE and equivalent cadres have come up for consideration of Special Grade Post as there is stagnation in the said cadres.

4) In the Whole Time Directors meeting held on 24-08-2017 approval has been accorded for sanction of SGP scale to the cadres of Superintending Engineer, its equivalent and above cadres in all services viz., Engineering, Accounts & P&G Service and who have completed six years of service in the same cadre with out getting any promotion.

5) After careful consideration, APTRANSCO hereby extends the Special Grade Post Scale to the Superintending Engineer, its equivalent and above cadres in all services viz., Engineering, Accounts & P&G Service as detailed below. An employee on completion of 6 years of service in a particular post shall be appointed to the Special Grade Post Scale which is the next higher scale above the pay scale of the post he/she is holding.
